President's Message -

Dear KOTAA members,

It is hard to believe that my two-year presidency is already coming to an end. Experts in time management say that one must begin with the end in mind. At the beginning of my presidency, the 2003-04 KOTAA staff envisioned a financially sound KOTAA Travel Grant by the end of our term that would not require delving into the base fund every year. I am pleased to report to you that we have accomplished that goal.

As you might remember from the annual meeting in January 2003, we received a significant donation (\$18,100) from the Korean Society of Pavement Engineering (KOSPE). Although the Korean economy was not particularly good at that time, a number of companies and individuals nonetheless donated graciously. In addition, the Korean Institute of Construction Technology (KICT) and the KOSPE have pledged another \$9,000 donation to be presented at the 2004 annual meeting. Based on the work of last term's KOTAA staff, the Korean Scientists and Engineers (KOSEN) also decided to donate an annual contribution of \$900. Finally, the Korean Society of Transportation (KST) has agreed to give the KOTAA about \$2,000 a year. The donations from KOSEN and KST represent annually recurring commitments which will provide a steady increase for the Travel Grant fund. Given the growing number of applications and increasing travel costs, these pledges are

also most welcome. We are exceptionally grateful for all these generous contributions and for the people who have recognized the tremendous benefits of the KOTAA Travel Grant fund.

During this fundraising effort over the last two years, I have met many Korean transportation engineers and administrators. I must tell you that these Korean colleagues clearly recognize the importance of our presence and mission. I believe that the KOTAA has grown into a mature organization of which we should feel proud to be a part. With your continuing support, we can make an even greater impact on the professional careers of all the members, on the advancement of transportation engineering in Korea and America, and on the betterment of future generations of Korean-American transportation engineers.

In closing, I appreciate the solid foundation the previous KOTAA presidents have established. Without that foundation, we could not have had the success we have enjoyed over the last two years. Also, my thanks go to the current KOTAA staff members for their endurance of endless emails and my charges. I must acknowledge the great effort put in by our secretary, Mrs. Seri Park. We talked, but she did most of the work. She has given her time graciously and willingly in the midst of her busy schedule as a student, as a new wife, and as a new mother. I appreciate her work.

I look forward to continuing to work with all of you and to enjoy fellowship in the coming years. Wishing you the very best for 2004, I remain
